




### Fig.1 Power Dissipation Derating Curve


Fig.2 Maximum Safe Operating Area






## Fig.4 Single Pulse Maximum Power dissipation

Fig.6 Typical Output Characteristics(II)






Fig.7 Breakdown Voltage vs. Junction Temperature









### Fig.8 Typical Transfer Characteristics

# Fig.10 Forward Transfer Admittance vs. Drain Current










Fig.11 Drain Current Derating Curve

Fig.12 Static Drain - Source On - State Resistance vs. Gate Source Voltage


Fig.13 Static Drain - Source On - State Resistance vs. Junction Temperature








## Fig.16 Static Drain - Source On - State Resistance vs. Drain Current(III)

Fig.18 Switching Characteristics




Fig.19 Dynamic Input Characteristics






Fig.20 Source Current vs. Source Drain Voltage








